Storage Options & Rates

Drying Rate:	\$0.04 per point removed (on Gross Bushels). Corn over 24% subject to rejection
House & Warehouse Receipts	\$0.07 per month per bu. billed daily
Price Later:	\$0.055 per month per bu. billed daily (Expires Oct. 22, 2026)
Rollover Price Later:	\$0.16 for 60 days and \$0.055 per month per bu. billed daily (Expires Oct. 21, 2027)
Free Price Later:	If offered, free until expiration on October 22, 2026
Grain Bank (Delivered):	60 Days free and \$0.04 per month per bu. billed daily (if free price later is offered then free until August 15, 2026 and \$0.04 per month per bu. billed daily after)
Grain Bank (Purchased):	30 days free and \$0.04 per month per bu. billed daily

Overall Grain Policy Rules:

- All grain deliveries must designate grain ownership prior to unloading. Signs are available for your delivery vehicle and must be clearly displayed. Each sign will designate the grain unloaded to an individual grain lot to accumulate and average. Patronage is paid on bushels of grain delivered for sale to Hull Coop and accumulates on the account(s) of the sign displayed (non-transferable).
 - All grain must be settled within 10 days of final delivery of a lot of grain or not more than 30 days following the date of first delivery on the lot. Grain will be stored on House Receipt automatically after this time elapses and accounts will be billed. Storage is charged from the average delivery date of the lot.
 - A grain lot will not be able to be combined with other lots or ownership groups for moisture averaging or other discount averaging purposes. The particular lot will stand on its own. If there is a new ownership split or the percentage of the split has changed, please inform the office prior to delivery.
 - If an owner settles out (sells, transfers, etc) grain from a particular lot, that lot will be closed and no additional grain can be added for averaging purposes. Please remember this specifically in the case of wet soybeans or wet corn as receiving a check for partial settlement of a lot locks that lot at those discounts.
 - Transfers off of your lot are permitted in limited circumstances. If a transfer is done prior to completion of delivery, that will also lock the lot for moisture and grade averaging. Further delivery will begin on a new lot.
 - Transfer off of a lot to another customer will be denied in the following circumstances:
 1. Grain for which a security interest applies issued by a third party
 2. Physically delivered grain that is transferred with intent to place into grain bank
 3. At the discretion of Hull Coop
- Hull Coop reserves the right to deny the transfer of grain from one patron to another for any reason.
- All stored grain that is picked up will be charged a 15-cent receiving and a 15-cent load out charge in addition to storage applied at House Receipt rate.
 - Grain Bank – Defined as grain delivered to or purchased from Hull Coop for future use in processed feed or to be fed with protein purchase from Hull Coop.
 - Grain sold out of Grain Bank will be assessed storage fees at settlement equivalent to House Receipt storage rates.
 - Price later contract bushels cannot be transferred or placed into grain bank or storage. Free Price Later bushels cannot be used toward forward contracts taken out for future months.
 - Green damage on soybeans – subject to special discounts at discretion of Hull Coop.
 - Treated Soybeans will not be accepted under any circumstance.
 - Damage on Soybeans – All damage designations will also count toward total damage discounts.
 - Discounts will not be averaged within the lot unless specifically noted.
 - Grain is purchased during regular trading hours of the CBOT and basis is subject to change at any time without notice

Hull Coop reserves the right to make changes or corrections to this policy at any time.

Hull Coop reserves the right to reject any delivery due to quality issues on any load of grain.
